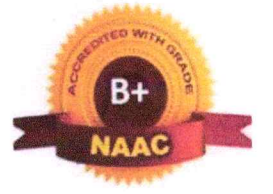
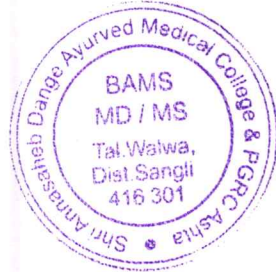

## **Description:-**

As we know that Drug is an important and integral part of Treatment. So Knowledge of Ayurvedic Medicines is very important. Pharmacovigilance is a word made up of Pharmakon which means is Drug and vigilance is to keep watch or to keep alert or awake. Pharmacovigilance is a science of collecting, monitoring , researching, assessing and evaluating information from health care providers and patients on the adverse effects of medications,biological products, herbal and traditional medicines with a view to identify new information about hazards associated with medicines preventing harm to patients. To understand these concepts and the present status of Pharmacovigilance "BHESHAJA SURAKSHA - 2022" National Webinar on Pharmacovigilance of Ayurvedic Drugs was organized by Institutional Pharmacovigilance Cell.

As this event was conducted online, initially Google form was prepared for registration of webinar and it was distributed online to all possible contacts. For this Webinar total 921 participants were registered from 17 various states (Maharashtra, Karnataka, Rajasthan, Andhra Pradesh, Madhya Pradesh, Uttar Pradesh, Gujarat, Uttarakhand, Tamilnadu, Kerala, Goa, Delhi, Chandigad, Daman, Punjab, Telangana and West bengal) of our country. Participant from Mauritius was also attended webinar.

The event was started at 09.45 am with admission of all participants and at 10.00 am the event was inaugurated by Hon. Prof. Dr. B. S. Prasad, President, Board of Ayurved, NCISM, New Delhi. Hon Dr Prasad sir in his inaugural speech explained the importance of understanding concept of Pharmacovigilance of Ayurvedic Drugs with some examples. Two sessions were conducted in this National webinar. The resource person for first session was Prof Vd Ravinarayan Acharya who is a Dean at ITRA, Gujarat Ayurved University, Jamnagar, Gujarat and the topic covered by him was "National Pharmacovigilance Programme for ASU Drugs". For the second session the Guest speaker was Dr Apoorva Sangoram, HOD, Department of Dravyaguna and Coordinator, PPvC, Tilak Ayurved Mahavidyalaya, Pune. The chairpersons for two sessions were Dr B. Ravishankar , Former HOD, Pharmacology Laboratory, IPGT&RA, Gujarat Ayurved University, Jamnagar, Gujarat and Dr John Disouza, Principa, Tatyasahe Kore College of Pharmacy, Warananagar.
